Mail Policies; SPAM, Junk E-mail and UCE are prohibited. Other restrictions include; using our network for the receipt of replies to unsolicited mass email (spam) sent from a third-party network or the forgery of email headers is prohibited.

Engaging in any activity that; Infringes or misappropriates the intellectual property rights of others, including copyrights, trademarks, service marks, trade secrets, software piracy, and patents held by individuals, corporations, or other entities; Violates privacy, publicity, or other personal rights of others.

Obscene Speech or Materials; Using our services to advertise, transmit, store, post, display, or otherwise make available pornography. Pier-Point shall notify law enforcement agencies when it becomes aware of the presence of child pornography on or being transmitted through our services.

Promoting Violence or Injury; Advocating, promoting or providing assistance in carrying out violence or any other unlawful activity against any persons, animals or any governments, businesses or other entities.

Defamatory or Abusive Language; Using Pier-Point's services as a means to transmit or post defamatory, harassing, abusive, or threatening language. Illegal or Unauthorized Access to Computers or Networks; Accessing illegally or without authorization computers, accounts, or networks belonging to another party, or attempting to penetrate security measures of another system (often known as "hacking"); Engaging in any activity that might be used as a precursor to an attempted system penetration (i.e. port scan, stealth scan, or other information gathering activity). Distribution of Internet Viruses, Worms, Trojan Horses, or Any Other Destructive Activities;

In the event that you engage in any of the activities above, and as determined by Pier-point to be abusive or disruptive, We may take any one or more of the following actions in response to abuse or complaints; Issue warnings: written or verbal. Suspend the account and access. Terminate the account and access. Bring legal action to enjoin violations and/or to collect damages, if any, caused by violations. Accounts with violations of these policies will not be eligible to receive a refund under any circumstance.
